I acknowledge that I have carefully read this Agreement and fully understand that it is a release of all liability of UWPC and CCWC and a waiver of any right that I, on behalf of myself or the Participant(s), may have to bring legal action against UWPC and CCWC. If any attempt for a legal claim is made, I understand I will be responsible for all legal defense cost incurred by UWPC and CCWC.

I agree that if any part of this Agreement is found to be invalid or unenforceable, the remainder of the Agreement shall remain in full effect.

I had sufficient time to read this Agreement in its entirety. I have read and understood this Agreement and agree to be bound by its terms.

Photography Release Agreement- The undersigned, on his or her behalf of the minor or minors previously identified, authorize the United Way of Porter County and Coffee Creek Watershed Conservancy (UWPC and CCWC) to publish photographs of us taken at the Family and Youth Day of Caring (FYDOC) on June 8, 2019, and our names and likeness, for use in UWPC and CCWC's print, online and video-based marketing materials, as well as other UWPC and CCWC publications, including but not limited to social media accounts of the UWPC and CCWC.
